The project 'Just Transition through Entrepreneurship' aims to support Ukraine's green recovery and just transition in the face of structural changes, economic challenges, and war-induced disruptions by providing holistic support for aspiring entrepreneurs, existing entrepreneurs, and entrepreneurial support organizations. The Ecosystem Builders Track works with business support organizations to develop services and programs for entrepreneurs in the region geared toward recovery and growth through creating avenues for sustainable, long-term support that extends beyond the duration of the program.

PROGRAM BENEFITS

By participating in the Ecosystem Builders Track of the 'Just Transition through Entrepreneurship' project, you have the chance to:

- Participate in **training sessions** on topics that are based on your organization's development needs
- Take part in a **two-day training bootcamp** that facilitates **collaboration with other business organizations**
- **Expand your international network** by connecting with German, European and Ukrainian experts
- Develop an **actionable roadmap for your organization** to enable you to upscale your organization

TARGET GROUP

1-3 representatives from a business support organization (BSO) that meets the following criteria:

- **Location:** based in one of the target regions and the majority of its member businesses are in one of the target regions (Volodymyr and Lutsk Raions in Volyn Oblast; Sheptytskyi, Lviv, and Zolochiv Raions in Lviv Oblast)
- **Stage of Development:** established within the last 10 years, focusing on developing and expanding their capacity to support local entrepreneurs.
- **Target group:** dedicated to supporting local small businesses and the local economy to grow and adapt to structural challenges.
- **Commitment:** Have representatives willing to engage fully in all program activities and demonstrate a commitment to long-term growth and sustainability.

ELIGIBILITY CRITERIA

Your organization:

- is legally registered in Ukraine, with a registration date between 2014 and 2024,
- is based in one of the target regions: Volodymyr and Lutsk Raions in Volyn Oblast; Sheptytskyi (formerly Chervonohrad), Lviv, and Zolochiv Raions in Lviv Oblast,
- focuses its activities and purpose on supporting enterprises and business activities located in the target regions in Ukraine,
- at least 80% of members are MSMEs based in one of the target regions,
- has the capacity to commit 1-3 representatives to fully participate in all program activities.

Your representatives:

- are over 18 years of age,
- are employed by, legal representatives of, or natural persons working under a direct contract with the Business Support Organization.
